## 74/19 Questions and comments from visiting councillors and members of the public

**Mike Woodward** asked what the current strategy is for the Sunningwell village pond. James Greenman explained that he arranged separate meetings with two consultants, and each was asked to present a proposal. The clerk was asked to seek an update.

**District Councillor Emily Smith** gave an update on the status of the local plan with emphasis on the County's unmet housing need, and the Oxford City requirements. The latest district councillors' report is due shortly.

**Bob Johnston** was unable to attend the meeting but sent in a written report, commenting on the County's plan to give Oxford City an agency agreement to run the Park and Ride sites under a common management regime. The County's Waste and Minerals Plan Part 2 is delayed due to the large number of responses. The County Cabinet has signed off a new Domestic Waste strategy with the aim of increasing the recycling rate to 70%.

#### 79/19 The pavement on Brumcombe Lane

Councillor Paul Darby expressed concern that the pavement in front and to the side of 5 Brumcombe Lane is no longer evident. The clerk was asked to write to Oxfordshire County Council to ask them to review the matter and re-instate the pavement.

# 85/19 The Oxford to Cambridge Expressway.

Cllr James Greenman suggested the Parish Council should join the North and West Parish Expressway Group (NAWPEG). A discussion followed and it was agreed that the Parish Council would join NAWPEG and support the No Expressway stance on condition that, in case this stance did not succeed, NAWPEG would also prepare a fall-back plan in support of one or more of the eastern routes.

Similarly, it was agreed that the Council would join the No Expressway Alliance.

## 86/19 Planning Applications.

The application P19/V0290/FUL for the bungalow at 2 Sunningwell to be replaced by two dwellings was refused by the District Council as inappropriate development in the green belt.

Cllr James Greenman reviewed the latest update to P19/V0169 for 200 dwellings on land North West of Abingdon and offered no further comments to the District Council.
